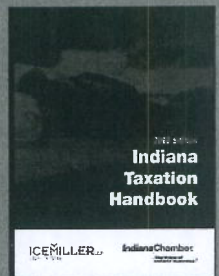

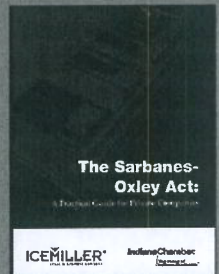
Taxation Handbook: 2011 Edition
